

ORDINANCE NO. 9-9-2020-1

AN ORDINANCE MAKING APPROPRIATIONS FOR THE SUPPORT OF THE CITY OF GOLIAD, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021 AND ADOPTING THE ANNUAL BUDGET OF THE CITY OF GOLIAD, TEXAS FOR THE 2020/2021 FISCAL YEAR.

Whereas, a Proposed Budget for the fiscal year beginning October 1, 2020 and ending September 30, 2021, for the City of Goliad, Texas was duly filed with the City Secretary on July 24, 2020, and was duly presented to the City Council by Mayor Trudia Preston by and through City Administrator Kandi Hubert; and

Whereas, a NOTICE OF MEETING and public hearing of said proposed budget was published in the newspaper at least ten days before and not more than thirty days before the public hearing and posted on August 27, 2020, and said meeting was held on September 9, 2020 in accordance with said notice.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GOLAID, TEXAS;

SECTION 1. That the appropriations for the fiscal year beginning October 1, 2020 and ending September 30, 2021, for the Support, Maintenance and Operation of the General Government of the City of Goliad, Texas be fixed and determined for said term in accordance with the expenditures shown in the City's Annual Budget for Fiscal Year 2020-2021, a copy of which is attached hereto as Exhibit "A."

SECTION 2. That the appropriations for the Fiscal Year beginning October 1, 2020 and ending September 30, 2021 for the payment of Debt Service requirements of the City of Goliad be fixed and determined as for said term in accordance with the payments shown in Exhibit "A."

SECTION 3. That the budget, as shown in words and figures in Exhibit "A", is hereby approved in all respects and adopted as the City's Annual Budget for the Fiscal Year beginning October 1, 2020 and ending September 30, 2021.
