The regularly scheduled Goliad City Council Meeting was held on February 28th, 2018, at 6:00 PM. in the Goliad City Hall, located at 152 W. End Street in Goliad Texas. The following Council members were present or absent as recorded below:

Mayor Preston called the meeting to order at 6:06 P.M. and announced that there was a quorum present.

The invocation was given Mayor Pro Tem Rodriguez and the Mayor led the pledge of allegiance to the American flag and Texas flag.

**Citizens Comments**

Mr. Cliff Prout, owner of the Goliad car wash, stated first that the car wash is open. Mr. Prout then requested to address Mr. Lill regarding posts that have been attributed to Councilman Lill via social Media. Initially Mr. Prout began by stating that the posts that have been seen on FACEBOOK infer that he borrowed \$20,000.00 from MDD for his car wash and the loan was not repaid. Mr. Prout stated that this was misinformation and he believed it was slander as he has never borrowed any money from MDD therefore there was nothing to be paid back. Mr. Prout had the Mayor read the Facebook page into the records (See attached) and stated that Mr. Lill was not to be believed. Mayor Preston requested Mr. Prout address the matter with the City's financial officer.

**Discuss, Deliberate, Consider, Take Final Action (s) and Vote on requesting AEP to install a street light across from St. John's Lutheran Church on Market Street,**

Councilwoman Burns moved to request AEP install the light for the Lutheran Church, the City to incur the cost with the stipulation no neighbor has a rebuttal. The motion died for lack of a second. There was no formal action taken.

**Discuss, Deliberate, Consider, and Take Final Action and Vote on disposal of the City's excess computers.**

Councilman Lill moved to send the excess computers to be recycled. The motion was seconded by Mayor Pro Tem Rodriguez. For: Unanimous. Motion carried 3-0.


The Mayor adjourned the meeting at 7:33 p.m.
